## FINANCIAL AGREEMENT

- Renter must pay the balance due not less than 28 days before check-in, otherwise, this Rental Agreement may, at Arrowhead Lodges' option, be canceled, and any reservation deposit made will be refunded, less a \$60 processing fee.
- Funds received less than 28 days before check-in must be in the form of credit, cash or a cashier's check.
- Should renter cancel more than 28 days before check-in, renter's deposit will be refunded in full, less a \$60 processing fee.
- Should renter cancel less than 28 days before check-in, proprietors may keep all monies received up to the amount of the scheduled rent paid, and any other monies paid by renter will be refunded. Should the proprietors re-rent the premises for all or part of the term specified above, renter shall be entitled to a refund of the monies paid, less the difference between the amount renter paid and the monies derived from such re-rental, plus \$60 processing fee. Trip insurance encouraged.
- Proprietors are not responsible for their own cancellation of the Rental Agreement by reason of the sale of the property, fire or other casualty, extreme weather, holding over by prior renter/guests, or any other reason.
- Renter's cleaning/security deposit to be refunded in full within 14 days of check-out, provided premises are left as found. Renter agrees in advance that automatic deductions may be made for any cleaning or damage repair resulting from renters'/guests' use of premises, in addition to all remedies provided by law. If repair amounts exceed deposit, renter agrees to pay difference within two weeks of billing. Renter pre-authorizes snow clearance fees deductions from deposit.
- Should snowfall require parking clearance, renter agrees fee may be paid from any deposit type without prior approval.
- Renters agree to be solely responsible for their physical safety and personal property while on premises. Blue Vista Lodge owners and affiliates are not liable for any property damage, theft, or physical injury sustained during renters'/guests' stay. This includes the deck, where guests are hereby notified that rail spacing is not child or pet safe. Arrowhead Lodges may void this contract at any time, and remove guests without refund of rent or deposit. Renters are liable for all property's losses and damages during-or-as-a-result-of their stay, regardless of length or deposit amount. Renter agrees to settle disputes at Arrowhead Lodges' chosen court locale, waiving their right of service. A five hundred dollar fine will be levied for any falsification of information herein, or court proceedings resulting from renters'/guests not honoring this agreement.

## CONTRACTUAL ARRANGEMENT *(Violation of any of the rules contained herein may result in automatic loss of deposit)*

- Price includes these free items: keypad entry, beds made, towel sets, local phone service, and one hour housekeeping.
- Renters must follow local quiet laws. Must not park on street, must leave Lodge as found and must follow all instructions posted at the Lodge, listed online at [www.BlueVistaLodge.com](http://www.BlueVistaLodge.com) or contained in e-mails sent by Arrowhead Lodges staff.
- Smoking is not allowed on property. Burning of charcoal in the grill means an expensive grill replacement at renter's cost.
- Trash service is free. Guests may place up to two 30-gallon bags inside the receptacles provided, with lids tightly closed (to protect from animals). Do not leave bags outside, do not put trash in the recycling bin. Pick-up is Tuesday morning. Any additional trash must be removed from the premises, or left inside (bagged, no leakage). \$5/bag removal fee.
